## Beginnings

The Foundation began in 1987 at the Defense Language Institute (DLI) at the Presidio of Monterey, California. Today, the Foundation is an independent, public, 501 (c) III organization.

## Programs

- Cultural Enrichment program (CEP) which provides funding for host-country sabbaticals and immersion courses for language teachers
